## Effective July 1, 2020 our Funds Availability Policy (check hold) will be changed to the following:

We are increasing the amount we make available for withdrawal by checks not subject to next day availability from \$200.00 to \$225.00. In addition, the amount available for withdrawal on exception holds for large deposits, new accounts and the amount for determining a repeat overdraft, increases from \$5000.00 to \$5,525.00. The cash amount of funds made available when using the ACT's permissive for withdrawals by cash or other similar means from \$400.00 to \$450.00.
